

“LOGAN” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is Twentieth Century Fox Home Entertainment Pty Ltd (ABN 16 007 525 920 of Level 3, Building 61, Fox Studios Australia, 38 Driver Avenue, Moore Park NSW 2031.
3. Entry is only open to Australian residents aged 15 years or over. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, defacto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
